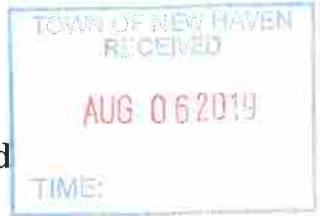

I, Lonie Parker of Porkys Place, at 7404 Rt 7 New Haven VT am requesting an amendment to my existing permit.

#1 Requesting permission to leave the port-o-let on sight for the event season. (May thru Oct)

#2 Would like to be able to serve alcohol (not just beer and wine) outside under the pavilion, as we already are serving this in the restaurant/bar, and on the back deck seating area.

#3 The wall issue needs to be clarified. The wall we closed in is the west wall that faces Rita Booskas property. We also wrapped the outer corners 10 ft on each side (the north and south) to reflect the noise into the field and away from Ritas house. This was discussed at the last meeting and should be on the recordings. The east wall will eventually have a drop down curtain as well as 2/3's of the north and south wall.
