TOWN HIGHWAY RECLAMATION AND PAVING

INVITATION TO BIDDERS

The Town of New Haven is inviting bids on the following as described below:

- Paving on two town roads

Bidding may be for reclamation and/or paving. Paving quotes should be for both virgin asphalt and recycled asphalt pavement (RAP). Should the Selectboard approve the use of recycled asphalt, the percentage of RAP shall not exceed 15%.

The Firms interested in these contracts must submit a bid on the attached Bid Forms. The Bid Forms must be filled out completely in ink. If you make a change, the person signing the form must initial the change.

Sealed bids are to be submitted to the Selectboard or Town Clerk at the Town Offices, 78 North Street, New Haven by 4:00 p.m. May 6, 2025; work is to start as soon as possible after the contract is awarded. However, bids must be valid for a minimum of thirty (30) days from date of opening for reclamation bids, and 60 days for paving bids.

The selected contractor(s) shall be responsible for providing adequate traffic control and adequate safety/warning signs during the project. The selected paving contractor is also required to provide adequate transitions to match intersecting roadways and driveways. Where necessary, the transitions may extend to the limit of the highway right-of-way.

Work shall conform to the latest State of Vermont Agency of Transportation Standard Specifications for Construction. The quantities noted for the bid items are approximate, being given as the basis for the comparison of bids. The Selectboard of the Town of New Haven reserves the right to increase or decrease the work and amounts stated in the bids as may be necessary, to reject and or all bids received; to waive any informalities in the bids or to accept any bids should the Selectboard deem it in the best interest of the Town.

SCOPE OF WORK

Location and description of Work: -

The street is as follows:

1. A section of South St starting at the intersection of River Rd and South St, heading north for 7,662 ft, applying a .75” base coat and a 1.25” top coat.
2. A section of River Rd starting near 3105 River Rd and continuing East for 6,058 feet, applying a .75” base coat and a 1.25” top coat.

Contractor is to include:

- **application of tack coats to state specified application rates;**

- **traffic control;**
- **sweep roadway as necessary.**
- **Adequate dust control**

All work is to meet or exceed State of Vermont Agency of Transportation Standard Specifications for Bituminous Concrete Pavement. The Town may require use of virgin asphalt. The Town may accept or reject any or all bids.
