

**Selectboard Public Hearing on GHR Enterprises, LLC Salvage Yard Permit**

Bruce Many called the Hearing to order at 6:50pm, (meeting delayed due to miscommunication on start time) this is a Public Hearing for GHR Enterprises, LLC for continuing to operate a salvage yard at 7531 Ethan Allen HWY.  
Bruce Many opened the meeting up to questions.

**Bruce Many** – Asked if Heffernan owned the property.

**Steve Heffernan** – The closing is next Thursday.

**Steve Dupoise** – Will you continue what Floyd Bartlett was doing?

**Steve Heffernan** – They will crush / bale, not doing any auto repair and no sale of parts. Everything will go to scrap.

**Steve Dupoise** – How often will you bale?

**Steve Heffernan** – Once a month, this may increase depending on volume of cars; it may increase to twice a month. His crusher runs at 100 – 110 decibels. Their hours of operation will be Monday – Friday 8am – 4 pm and Saturday's 8 – noon, there will be no crushing on the weekends; they will just take in cars.

**Cale Roberge** – The machine can crush 20 - 30 cars in an hour.

**Bruce Many** – Are you buying the entire property that includes the rental houses?

**Steve Heffernan** – Yes, the 3 rental houses are included in the sale. He will set up a second enterprise to manage the rentals, so it is not associated with the Salvage Yard

**Kathy Barrett** – What will you do with the oil and other fluids.

**Steve Heffernan** – He will use the waste oil to heat the garage on location, or his other salvage yard locations. The State regulates how much waste oil, antifreeze he can have on site. He added the State does regular inspections.

**Dean Gilmore** – What will gas be stored in.

**Steve Heffernan** – They can legally store up to 375 gallons on site, stored in barrels in a building or trailer, all will be properly marked.

**Kathy Barrett** – Suggested Steve Heffernan invite the Fire Department to view the salvage yard.




